This information can also be sent electronically. My personal details will be processed by the third-party service providers and the Insurer for the purposes of identification and the provision of the services used. Insofar as is necessary for the provision, execution and charging of the services used, I authorize Swisscard to exchange information concerning me with the insurer, Traveler Buddy and Priority Pass

as well as with other domestic or foreign third parties involved (e.g. lounge operators), if necessary using electronic systems operated by third parties. To this end, and to an appropriate extent, I release Swisscard of all obligations to secrecy.

I am aware that electronic sharing of information involves information being transported via an open international network that is accessible to anyone. Even with appropriate data encryption, data may be viewed by third parties, thereby allowing these third parties to infer an existing or future business relationship between myself and Swisscard. Furthermore, I acknowledge that data disclosed to third-party partners of Swisscard are not governed by data protection equivalent to that applicable in Switzerland.

## CONDITIONS OF THE SWISS MILES & MORE TRAVEL PACKAGE

- ✓ By signing this document, I accept the conditions of the third-party service providers, Traveler Buddy and Priority Pass, and in particular accept that, for the purposes of registration, Swisscard will pass on my personal details to the third-party provider and am aware that my details, when in the possession of the third-party provider, will not be governed by data protection provisions equivalent to those applicable in Switzerland.
- ✓ I confirm that I have carefully read and understood the conditions of insurance and the collective insurance information (which can be consulted at [swisscard.ch](http://swisscard.ch)) and that I accept them unconditionally, in particular with regard to data exchange (section 11 of the General Terms and Conditions of Insurance).
- ✓ The monthly fee for the relevant SWISS Miles & More travel package will be charged directly to my card account.
- ✓ The insurance cover will be provided as a secondary card benefit. By providing insurance cover, Swisscard performs related administrative tasks (e.g. management of financial statements, collection of premiums, damages administration, statistics). Swisscard receives customary remuneration from the insurer for any personnel, technical (e.g. IT infrastructure) and other expenses related to the brokerage and handling of the insurance cover. I acknowledge Swisscard's entitlement to this remuneration from the insurer.
- ✓ The SWISS Miles & More travel package selected is valid for one year from the confirmation of the contract and can then be canceled in writing following a period of notice of 30 days at the end of a month. The cancellation applies to all benefits included in the relevant SWISS Miles & More travel package.
- ✓ In any event, the relevant SWISS Miles & More travel package ends with the termination of the card agreement in accordance with the Swisscard General Terms and Conditions.
- ✓ I acknowledge that Swisscard reserves the right to adjust the benefits provided within the framework of the relevant SWISS Miles & More travel package as well as the associated prices or to cancel the relevant SWISS Miles & More travel package at any time.
- ✓ Changes to the conditions of insurance will be announced in writing at least three months before taking effect and are deemed to be approved if the customer does not cancel the agreement in writing before the change takes effect. Cancellation is valid if it is received by Swisscard no later than the final day before the change takes effect.
